### TERMS AND CONDITIONS OF USE OF THE Website

This page describes the terms and conditions of use (hereinafter the "Terms and Conditions") under which the Universidad de Monterrey (hereinafter UDEM) offers any user access to various information provided by UDEM, including but not limited to, information on: (i) general content, data, text, drawings, images, statistics, writings, music, news, software programs, files, graphics, video, photographs, sounds, messages (hereinafter the "Content") made available to you.

#### OBJECT

By using the Website, UDEM offers and facilitates User access to Content, which includes but is not limited to the following: (i) Information about UDEM, (ii) Academic Programs, including High Schools, Undergraduate Programs, Graduate Programs, and International Programs (exchange programs) (iii) Information related to UDEM activities (hereinafter the "Services").
